A few words from the chair

DSE was founded in 1976 to support education and research on Europe and the EU in Denmark. In light of the dramatic events unfolding daily in the Euro-crisis, along with the coming Danish Presidency of the Council, there is a pressing need for scholarly knowledge and debate about Europe and the EU in Denmark.

Given the complex nature of the challenges facing the EU, DSE's goal of interdisciplinary exchange between different fields (economics, history, law, political science and beyond) is also even more relevant today.

The annual DSE meeting held in Odense on the 29th-30th of September, 2011 was a good opportunity to take stock of the study of Europe in Denmark. Over 50 Europeanists presented research representing the impressive quality and breadth of our research community. A warm thanks is hereby sent to the organizers (Christilla Roederer-Rynning and Niels Lachmann).

Professor Finn Laursen was also presented at the meeting with an honorary membership of DSE for his lasting contributions to the field in Denmark through research, teaching and professional work.

DSE has introduced a small fund for supporting research activities on Europe in Denmark, especially those that promote cooperation between institutions.

The DSE Fund was approved by the board at the annual meeting in September 2011. The text of the fund and procedure for application is the following (in Danish).

Procedure til DSE støtte af Ph.D. netværk og forskningseminar

DSE støtter aktiviteter som fremmer forskning om det europæiske samarbejde i Danmark. Forankringer ligger i studiet af den Europæiske Union (EU), men andre organisationer og relationer er også relevant.

Der er to formal som kan støttes finansielt af DSE med beløb på op til 5.000 kr per ansøgning, særligt projekter som fremmer samarbejdet mellem DSE's medlemsinstitutioner.

- 1) Oprettelse og driften af et netværk af Ph.D. studerende i Danmark som studere europæisk integration, bredt forstået.
- 2) Understøttelse af forskningsseminar og lignende videnskabelige aktiviteter afholdt i Danmark med fokus på europæisk integration, bredt forstået.

Proceduren:

Der kan løbende indsendes ansøgningen til DSE, som efterfølgende vil blive behandlet i bestyrelsen. Ansøgningen skal kort beskrive aktiviteten (maks 1-2 sider), projektets deltagere, samt indeholder et detaljeret budget (maks 1 side) og en CV af ansøgeren (maks 1 side). Der er ikke en skema til selve ansøgningen.

Ansøgningen skal indsendes til DSE's formand, og henvendelse vedrørende støtte kan også rettes til DSE's formand.

Ansøgningen skal godkendes af et simpelt flertal af de tilstedeværende bestyrelsesmedlemmer. Ansøgeren vil få besked umiddelbart efter behandling – senest tre måneder efter indsendelsen.

Hvis der gives støtte forventes det, at der skal indsendes rapport og bilag om aktiviteten til kassereren og formanden senest 3 måneder efter det er afholdt.

Dansk Selskab for Europaforskning (DSE) blev dannet i 1976 med henblik på at inspirere og støtte diskussioner om udviklinger i Europa.

DSE har to officielle formål. DSE skal fremme forskning og undervisning i alle aspekter af europæisk samarbejde – administrative, politiske, juridiske, økonomiske, og sociale. Forankringer ligger i studiet af den Europæiske Union (EU), men andre organisationer og relationer inddrages også. DSE skal desuden fremme samarbejdet mellem DSE medlemmer og andre foreninger med et tilsvarende formål.

DSE tilhører medlemmerne, og alle som fra en videnskabelig vinkel beskæftiger sig med Europa kan blive medlem. DSE's økonomiske råderum udgøres af medlemsindbetalinger. DSE modtager ingen former for offentlige støtte og er politisk som finansiel uafhængig.

DSE organiserer egne møder, heriblandt årsmødet. På møderne kan alle medlemmer fremlægge forskning og deltage i debatterne.
